

# **Biblical Principals of Estate Planning**

### **Definition of Christian Estate Planning:**

Wisely managing and controlling your property for you and your loved ones while you are alive and competent. Providing for your care and the care of your loved ones in the event of a physical or mental disability. On your death, giving what you have to whom you want, the way you want, when you want, all at the least possible overall cost in taxes, court costs, attorney's fees and administrative expenses, keeping Biblical principles in mind throughout.

As believers and with the Word of God as our guide, we are given His wisdom as shown in the few examples included here:

#### Matthew 5:42

"Therefore keep watch, because you do not know on what day your Lord will come. But understand this: If the owner of the house had known at what time of night the thief was coming, he would have kept watch and would not have let his house be broken into. So you also must be ready, because the Son of Man will come at an hour when you do not expect him."

#### 1 Timothy 5:8

"But if any provide not for his own, and specifically for those of his own house, he hath denied the faith, and is worse than an infidel."

- 4. Disability "Helpers"
- 5. Trustees
